OPTIONS:

- Promotional boat package purchase by State Chapter.** State BASS Federation Nation Chapters may purchase one (1) new (unused and not previously warranty registered) Skeeter/Yamaha boat package (“Boat Package”) from the models in the table below at the listed price during the Program Dates direct from Skeeter, via an Order Request Form. Boat Package orders must be postmarked or sent by facsimile and received by Skeeter prior to November 1, 2008. Boat Package must be pre-paid prior to delivery. State tax will be added to all orders if applicable. Boat Package is a standard package and will not include options or upgrades. Price does not include shipping, rigging, batteries, or Yamaha Extend Service (Y.E.S.) contract. Any additional requested options will be available at Dealer cost. No upgrades in models listed will be allowed. State BASS Federation Nation Chapter agrees to use the Boat Package for promotional fund raising purposes, including but not limited to, active fund raisers, prizes, sweepstakes, and raffles all promoted through the State BASS Federation Nation Chapter. State BASS Federation Nation Chapter shall be solely responsible for any promotional and fund raising activities associated with Boat Package and ensure that any promotional and fund raising activities are in compliance with all applicable laws, rules and regulations. Skeeter shall warranty register the Boat Package to State BASS Federation Nation Chapter in accordance with Skeeter’s standard warranty registration procedure at time of delivery. Skeeter shall transfer title to State BASS Federation Nation Chapter upon delivery and full payment of Boat Package. This Option 1 cannot be used in conjunction with Option 3 below.

- President Promotional boat package purchase.** State BASS Federation Nation Chapter Presidents may purchase one (1) Skeeter/Yamaha boat package (“Boat Package”) at 40% off MSRP during the Program Dates direct from Skeeter, via an Order Request Form. Boat Package orders must be postmarked or sent via facsimile and received by Skeeter prior to November 1, 2008. Boat Package must be pre-paid prior to delivery. State tax will be added to all orders if applicable. Boat Package is a standard package and will not include options or upgrades. Price does not include shipping, rigging, or batteries. Price does include a two (2) year Yamaha Extend Service (Y.E.S.) contract (Choice offered Florida is a 24 month Yamaha Limited Warranty). Any additional requested options will be available at Dealer cost. State BASS Federation Nation Chapter Presidents agree to use the Boat Package for personal or Chapter use. Skeeter shall warranty register the Boat Package to State BASS Federation Nation Chapter in accordance with Skeeter’s standard warranty registration procedure at time of delivery. Skeeter shall transfer title to State BASS Federation Nation Chapter upon delivery and full payment of Boat Package. This Option 2 cannot be used in conjunction with Option 3 below.

- Retail boat package purchases by State BASS Federation Nation Chapter Members.** State BASS Federation Nation Chapter Members who purchase one of the eligible Skeeter/Yamaha boat packages ("Boat Package") listed in the table on the next page, **by December 31, 2008 for in stock boats and November 1, 2008 for ordered boats**, from a participating authorized Skeeter dealer, will receive the listed CASH REBATE or have the option of assigning the CASH REBATE over to the participating authorized Skeeter dealer at the time of sale. CASH REBATE applies to any listed **eligible** new (unused, not previously warranty registered) in-stock or ordered Boat Package directly from a participating authorized Skeeter dealer. In addition to the listed CASH REBATE, qualified purchases by a State BASS Federation Nation Chapter Member will include a two (2) year Yamaha Extend Service (Y.E.S.) contract (Choice offered Florida is a 24 month Yamaha Limited Warranty). To obtain the CASH REBATE and the Y.E.S. contract State BASS Federation Nation Chapter Member must complete, with the participating authorized Skeeter dealer, the Skeeter REBATE CLAIM FORM, which must include the following documents and be postmarked or sent via facsimile and received by Skeeter no later than December 31, 2008 for in stock boats and November 1, 2008 for ordered boats: bill-of-sale for in stock boats or copy of original sales contract signed by Member and copy of Skeeter boat order initialed by Member for ordered boats, warranty registration confirmation, valid proof of your current/active BASS Federation Nation membership, authorized participating dealer signature. This Option 3 cannot be used in conjunction with Option 1 and 2 above.

4. **State BASS Federation Nation Chapter Retail Purchase Reward.** Each State BASS Federation Nation Chapter will have the opportunity to earn CASH REWARDS based upon each State BASS Federation Nation Member who purchases a new (unused, not previously warranty registered) and eligible Yamaha powered Skeeter boat under the Cash Rebate program pursuant to the terms and conditions of Option 3 above. The CASH REWARD equals three hundred dollars (\$300.00) for each qualified purchase that meets the terms and conditions of Option 3 above. CASH REWARDS will be given directly to each State BASS Federation Nation Chapter at the Bassmaster Classic event following the Program Dates. The "Rebate Claim Form" authorized, completed, and turned in by the deadlines, by the BASS Federation Nation Member at the time of purchase, will be used by Skeeter to compile the overall CASH REWARD for each State BASS Federation Nation Chapter. A form letter will be sent to each State BASS Federation Nation Member notifying them that they have earned their State Chapter a CASH REWARD. Likewise, a copy of that letter will be sent to each State BASS Federation Nation Chapter. Skeeter Boats will have the final say in qualifying and eligible purchases.

5. Terms and Conditions for the 2008 Skeeter/Yamaha BASS Federation Nation Program.

- Skeeter and Yamaha shall retain sole and final judgment in all matters concerning the 2008 Skeeter/Yamaha BASS Federation Nation Program (“Program”).
- This Program cannot be stacked or combined with any other Skeeter or Yamaha offer.
- Skeeter is not responsible for Boat Package orders postmarked or faxed after November 1, 2008 for factory direct ordered boats under Options 1 and 2. It is further understood that these requests will be denied with NO EXCEPTIONS.
- This Program is only applicable for eligible Skeeter models, in-stock or ordered, retail **sold or ordered during applicable Program Dates**. Any Boat Package sold or ordered before or after these dates is not eligible.
- This Program is **limited to available stock in dealer inventory or ordered boats that are sold, delivered and warranty registered on Y.M.B.S.** during the applicable dates. No model substitutions, rain checks or extensions will be allowed. **NO EXCEPTIONS.**
- NO BENEFIT SUBSTITUTIONS.
- Retail purchases by the State BASS Federation Nation Chapter Members, pursuant to Option 3, require a completed “Rebate Claim Form”, which must include the following documents: bill-of-sale for in stock boats and copy of original sales contract signed by Member and copy of Skeeter boat order initialed by Member for ordered boats, warranty registration confirmation, and valid proof of your current/active BASS Federation Nation membership, authorized participating Skeeter dealer signature. Rebate Claim Form with required documents must be postmarked no later than November 1, 2008 for ordered boats and December 31, 2008 for in stock boats.
- Rebate Claim Forms will not be reviewed for Program consideration and processed until Boat Package warranty registration is complete.
- This offer is invalid and cash rebate checks are void if cash rebate checks issued are not cashed within 180 days of issuance. Cash rebate checks will not be reissued.
- Skeeter rebate checks will be issued by Skeeter to the registered owner once Skeeter verifies that all terms, conditions and procedures of the Program have been successfully completed in accordance with the 2008 Skeeter/Yamaha BASS Federation Nation Program. **Please allow 4-6 weeks for Skeeter cash rebate to be processed** from the time the State BASS Federation Nation Chapter Member Rebate Claim Form is received by Skeeter Products, Inc. and warranty registration is confirmed so the rebate claim may be verified to comply with all Program terms, conditions and procedures.
- If the State BASS Federation Nation Member assigns the authorized and participating Skeeter dealer to apply the Skeeter rebate amount towards the purchase of the Boat Package, by checking the option to assign the rebate to the dealer, no check will be issued to the State BASS Federation Nation Member.
- Any 2008 **Skeeter BASS Federation Nation Rebate Claim Form** received with a postmark date or fax date after November 1, 2008 for ordered boats and December 31, 2008 for in stock boats will not be eligible.



- All eligible in-stock boats purchased by State BASS Federation Nation Members under Option 3 must be **warranty registered on the Yamaha Y.M.B.S.** by the authorized participating Skeeter dealer no later than **December 31, 2008**. Rebate Claim Forms must be sent to Skeeter via facsimile or mail and postmarked by November 1, 2008 for ordered boats and December 31, 2008 for in stock boats. Any Boat Package warranty registered after the applicable date is not eligible.
- This Program offer is only valid for eligible Boat Packages **warranty registered to original owners who are legal residents of the U.S.A.** This offer is not transferable. Any 2008 Skeeter/Yamaha BASS Federation Nation Program claims delivered to Skeeter that define an original Member's name to be different than the name warranty registered on Y.M.B.S. by the authorized participating Skeeter dealer will not be eligible for this Program.
- Only applicable for participating authorized Skeeter dealers in the U.S.A.
- Any Boat Packages warranty registered to authorized participating dealerships are not eligible for this Program.
- Skeeter is not responsible for any Order Request Forms or Rebate Claim Forms that are lost, damaged, late, misdirected, incomplete or illegible. Any requests that fall under any of these conditions will not be eligible for Program consideration.
- Boat Packages sold or provided directly by Skeeter for competition, tournament, sponsorship, or promotional purposes (i.e. Team Boats, tournament give-a-ways, and rep demos) are not eligible. Dealer Demos do qualify for this Program.
- Income and other taxes (if any) are the responsibility of the participant, State BASS Federation Nation Chapter and/or its Members.
- **This Program cannot be used in conjunction with any other offer made by Skeeter or Yamaha and other retail promotions, programs and any other special discounts.**
- Fraudulent claims will be prosecuted to the fullest extent of the law. This Program offer is void where prohibited or restricted by law.
- Skeeter reserves the right to change or cancel this Program at any time.
- Any Boat Package warranty registered to a fictitious name or for a sale to a third party that did not truly transpire will be grounds for a fraud investigation.
- Should Skeeter have to settle a dispute with a Member or Chapter who was not eligible for this Program because they failed to meet the Program requirements, the amount required to settle this issue will be charged to the Member and/or Chapter.
- Skeeter reserves the right to request a copy of any documents for any transaction submitted for Program consideration.
- In exchange for the consideration received under this Program, State BASS Federation Nation Chapters and Members agree to be bound by all terms and conditions of this Program.
