3. Attach valid proof of current/active state BASS Federation Nation Membership;
4. Attach proof of warranty registration. Must be warranty registered with in two weeks of sale through Y.M.B.S. Rebate Claim Form will not be processed until warranty registered.
5. Send all required documents to Skeeter. Must be postmarked or faxed by December 31, 2008.

**Ordered Boat: ALL PAPERWORK MUST BE POSTMARKED OR FAXED NO LATER THAN NOVEMBER 1, 2008 EVEN IF BOAT HAS NOT BEEN DELIVERED.**

1. Complete Rebate Claim Form;
2. Attach copy of original sales contract signed by BASS Federation Nation Member. Must be ordered and a completed member signed contract attached for sale of eligible product between March 15, 2008 - November 1, 2008;
3. Attach copy of Skeeter boat order, initialed by BASS Federation Nation Member;
4. Attach proof of warranty registration. Must be warranty registered with in two weeks of sale through Y.M.B.S. Rebate Claim Form will not be processed until warranty registered.
5. Send all required documents to Skeeter. Must be postmarked or faxed by November 1, 2008.

**Product Participation:** All new (unused and not previously warranty registered) In Stock and Ordered eligible boats retail sold during the Program Dates are eligible to participate in the 2008 Skeeter/Yamaha BASS Federation Nation Program.

**NOTE:** Boats which are purchased for promotional purposes, i.e. SKEETER Team boats, tournament discount, give-a-way, sales rep demo, other special discount will not be eligible for the retail program promotion. **Dealer Demos will qualify.**
